President's Message

Dear Neighbors,

Greetings and Happy Fall! Fall is a wonderful time of year and is also when the community holds its Annual Homeowners meeting. At this meeting, several important issues will be addressed, including election of officers to the Board of Directors, ratification of the 2010 budget, and whether the Homeowners' dues should be increased. Other issues will also be discussed and residents will have time to raise their own concerns. The meeting is scheduled to be held on November 17, 2009, 8:00PM, at the Occoquan Town Hall, 314 Mill Street.

If you should be unable to attend the annual meeting, please fill out a proxy and submit it to a member of the Board before the meeting, or designate any member of the community to submit the proxy at the meeting. You have two choices under the proxy, *i.e.*, to have it count towards quorum and vote, or to have it count only towards meeting the quorum. A quorum requires 50% plus one vote of the community to be present in person or by proxy for the meeting to be valid. A proxy was included with your Quarterly Dues Statement. A proxy is attached to this newsletter. You may also obtain a proxy from any member of the Board. Please keep in mind that renting the Occoquan Town Hall costs the community \$150, whether we have a quorum or not to conduct the meeting. So please make every effort to attend or to assign your proxy. The Board looks forward to your participation in this important community activity.

Two other issues have drawn repeated complaints from fellow residents and need to be addressed. The first issue is please do not put old TVs or computers or other electronic equipment out for trash pick-up as it will not be picked up by American Disposal Services, Inc., the company that picks up trash in the community twice a week. Please make other arrangements to discard such items. For example, you may dispose of electronics equipment at the Prince William County Landfill at 14811 Dumfries Road (Rte. 234), Manassas, VA 22192. The second issue is to remind all dog owners that Prince William County requires by law for dogs to be on a leash when outside of the owner's property, for owners to clean up after their dogs, and for owners to get their dogs licensed after they turn four months old and then annually after that. The fee is only \$5.00 per year. At the time of renewal you must show current vaccinations for each dog.
