Keep Occoquan Landing Home Prices Going Up

Frequent Complaints

In light of all the new residents and the fact that we can all use a helpful reminder every once and awhile, this month's newsletter will cover some of the more frequent resident complaints and everyday issues that we all need to abide by in order to live harmoniously with one another and be good neighbors.

Issue 1: Trash – Please note that trash bags should not be set out on the curb until after 8PM the <u>night before</u> garbage collection days which are Tuesday and Friday. This means that the earliest that trash should be curbside is on Monday and Thursday evenings. Trash collection usually occurs before 6:00 am on Tuesdays and Fridays so if you wait until the morning of, make sure you set it out in time.

<u>Issue 2: Pet Waste</u> – When walking your dog (on a leash), please be sure to carry some sort of bag with which to pick up the waste. No one likes to walk through the common areas (this includes the parks and areas behind the houses) and risk stepping in dog poop. It's common sense and it's courteous. The plastic grocery bags are great to use as pet poop pick-ups. ? Also, remember to keep your cats on your own property.

<u>Issue 3: Garbage Cans and Recycle Bins</u> – The guidelines state that garbage cans and recycle bins <u>cannot</u> be stored in the front of the house, even if something blocks their view from the street. We all have fenced in back yards which is the appropriate place for storing these items.

Trash Containers

Trash cans and recycling bins are not to be kept in the front of homes nor in bushes in front. According to the Covenants, Article II: 12. No Lot shall be used or maintained as a dumping ground for rubbish. Trash, garbage or other waste shall not be kept except in sanitary containers. Such containers shall be kept in a clean and sanitary condition. All materials or refuse shall be kept in containers inside the rear fence line and shall not be placed or stored in front of any house. All trash and garbage shall be placed...outside...only on specified trash collection days. The Association shall have the right to impound any trashcan or garbage receptacle, which is placed in violation of this paragraph, and to enter onto any Lot for this purpose.

Trash Collection

Trash Days

The following is the standard procedures to be observed when placing trash out for collection. Collection days are on **Tuesday and Friday ONLY.** Trash must be placed at the front of the townhouses or at previously designated collection points.

Trash is to be in closed plastic trash bags. All trash should be contained—do not put out any loose trash. Trash is to be placed out no earlier than 8:00 PM before the day of the pick-up and no later than 6:00 AM on the day of pickup.

Recycling

Recycling is picked up on Fridays. Metal cans, #2 plastic and newspapers are required to be recycled. The items must be securely placed in either a container supplied by the trash company or in a homeowner's personal container.

Recyclables are to be placed out no earlier than 8:00 PM Thursday and no later than 5:30 AM on Friday.

Reminder There are two open Board seats.

Please, if you are interested in participating as a member of the Board, contact one of the current Board members prior to the May 12th meeting. They will be more than willing to answer any questions/concerns you may have regarding service as a Board member.

The Architectural Control Committee (ACC) is looking for 1 member. If you are interested in participating as a member of the committee, please contact Steve Heath before the May 12 board meeting.

Under the Architectural Guidelines, the ACC's authority consists of: "...approving all requests for modification to the external appearance of any home within Riverview Overlook."

Members of the committee will be walking around the neighborhood examining the front and back exterior of all the Occoquan Landing homes. Citations for architectural violations will be sent out shortly thereafter.

Animals

According to the Covenants Article II:

9. Neither livestock nor fowl shall be kept on the Property. The breeding of animals for commercial use is prohibited, but nothing contained herein shall be construed to prohibit the keeping of the usual domestic pets. No more than two domestic pets shall be kept at any one time. Pets shall be restrained and controlled as required by ordinance now or hereafter promulgated by Prince William County, Virginia.

In Prince William County it is against the law to...

- Allow within the County prolonged or intense barking or other harsh or excessive noises to be made by animals and pets under one's ownership, at any time (Section 14-5.1).
- Allow your animal to trespass on someone's property after being requested by the owner of the property not to trespass (Section 4-4).
- Allow your animal to run at large within the County unless engaged in supervised, formal or science training classes, or show, or during formally sanctioned field trials or while engaged in lawful hunting during open hunting season (Section 4-23).
- Allow your animal to knowingly or willfully urinate or defecate on private property
 of other persons or on publicly owned property except parts of parks as posted as
 dog run areas (Section 4-11 & 4-26).
- Own a dog four months or older and not obtain a County dog license that your dog is required to wear, and a collar bearing said license (Section 4-46).
- Have knowledge of an animal which has bitten someone and not immediately notify the Animal Warden (Section 4-64).

Remember it is your responsibility to clean up after your pet!

Crafts for Kids - Note Holder for Mom (craft time is 30 minutes plus drying time)

Materials (can be purchased at Michaels®):

Acrylic paint (three colors of your choice); clothespins, spring-loaded, 2-inch, 3; craft sticks, 2½-inch, 11; craft glue; paint pens (three colors of your choice); wood plaque, 5-inch x 7-inch

Instructions:

- 1) Apply a coat of acrylic paint to the top and side edges of the plaque. Paint the craft sticks another color and the clothespins yet another color. Let paint dry completely.
- 2) Break one craft stick in half to make the top and bottom of the O. Glue craft sticks onto plaque to form the word "Mom". To center the word on the plaque, position the O first.
- 3) Glue three clothespins onto bottom of plaque as shown.
- 4) Use paint pen to make flowers on the craft sticks and clothespins. Draw a line around one ridge on the side edge of the plaque.
- 5) Glue ribbon on back of plaque to make a hanger.
- 6) Give to Mom for Mother's Day!

RE: Parking

At a duly called and well-attended Annual Meeting on November 8, 2004, residents voted to restrict parking on Rivershore Drive to visitors only. The Board in its duties must implement the will of the body at the annual meeting. However, Board members recently received a copy of a petition signed by a majority of the owners regarding parking on Rivershore Drive that requests the decision of the community be rescinded. Given the number of signatures and the fact that a petition cannot override a vote taken at an annual meeting, the Board hereby calls a special meeting for the sole purpose of deciding how parking on Rivershore Drive will be treated.

Background Information

There are 117 homes in our community. Each home has 2 assigned parking spaces. In addition there are 21 marked visitor spaces. Depending on how cars are parked, 12 additional vehicles can be parked on Rivershore Drive. The Board is aware of 2 houses that have 5 cars; 3 houses with 4 cars; and 12 houses with 3 cars. 17 houses take an additional 23 spaces. Undoubtedly, there are more vehicles that the Board is not aware of since some residents are constantly switching their personal vehicles among visitor parking spaces. In addition, some houses have more than 2 vehicles, but have parked them outside of the community. Also, there are others who want to have more vehicles, but realize that each house has only 2 parking spaces. Another problem is that vehicles from the neighboring townhome community sometimes park on Rivershore Drive. Once in a while abandoned or stolen cars are parked on Rivershore.

Regulations

The Parking Committee will be distributing the current approved Parking, Architectural Control and Trash/Animal Regulations and visitor (parking) decals in the next several weeks. The visitor (parking) decals will have identifying information on them. The Parking Regulations as amended will take effect as soon as the decals have been distributed except no action will be taken with regards to Rivershore parking until after the Special Meeting.
